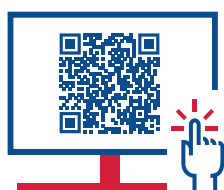


1. INTRODUCTION

FC Barcelona's involvement in actions to ensure the wellbeing of children and young people has increased over the course of its history, mirroring growing social awareness and embracing innovative practices. The establishment of the **FC Barcelona Foundation** in 1994, with its focus on the promotion of projects to benefit children, initially in Catalonia and since 2003 in numerous countries worldwide, reflects this trend, as does its commitment to the development of its youth academy teams and the global alliance formed between the FC Barcelona Foundation and UNICEF in 2006.

Since 2017, the FC Barcelona Foundation has also focused an entire branch of its work on prevention, early detection and intervention aimed at addressing peer-to-peer bullying, which encompasses many elements in relation to the safeguarding of young people.

In 2018, FC Barcelona formalised a set of best practice guidelines for the **safeguarding of children and young people** in the club's initial internal documents, aiming to systematise the knowledge acquired through experience. A process to review and expand the FC Barcelona and FC Barcelona Foundation Child Safeguarding System was initiated in 2021, with the support of Espirales Consultoría de Infancia, which included internal training and coordinated efforts across the different areas of the club. All of these activities led to the approval, publication and dissemination of the following documents in June 2022, which have been made available on a specific Child Safeguarding page of its website:

Based on the principles of transparency and accountability that characterise the rights-based approach, this report documents the activities conducted during the 2022-2023 season within the framework of the Child Safeguarding System described in the documents listed above, as well as presenting various conclusions regarding the results achieved and setting objectives for the future.

2. ACTIVITIES IMPLEMENTED

2.1. TRAINING ACTIVITIES

FC BARCELONA TRAINING ACTIVITIES

The new **Child Safeguarding System** was introduced during the 2022-2023 season and, as such, much of the initial work for that year was focused on providing relevant training for its teams of professionals, in accordance with this model. We are happy to report that all teams now have Safeguarding Delegates and Coaches in place, so that all the children and young people involved in FC Barcelona activities have access to designated, trained personnel working to ensure their wellbeing, as shown in the table below.

The participation of the professional teams in the training sessions was extremely positive, with sessions provided in different formats (in-person, online and hybrid) and the depth of learning and length of the courses tailored according to their responsibilities. Lessons were learned that can be applied to future training sessions, both for new joiners and as part of the annual knowledge update sessions.

The FC Barcelona Foundation also worked alongside some of the collaborating entities to review their child safeguarding systems, which involved requesting information with regard to their child safeguarding policy to verify its alignment with the FC Barcelona Foundation’s safeguarding system, the contact details of the project’s relevant safeguarding personnel, as well as the local safeguarding circuits and routes in force in the area.

2.2. COORDINATION ACTIVITIES

Coordination activities consist of internal actions to agree on areas of work, discuss and approve proposals and implement the necessary actions to achieve the different objectives.

A working team was set up to manage the Child and Young Person Safeguarding System materials production and organisational process, which operated from the beginning of 2021 until the middle of 2022. In line with the structure set out in the materials, the **Safeguarding Committee** was constituted in July 2022, which was then approved, along with all the documentation that makes up the Safeguarding System, by the Board of Directors and the club's members on 30 November 2022. The members of the Safeguarding Committee are:

- ▶ **Director of the FC Barcelona Foundation:** Marta Segú.
- ▶ **Director of the Legal Area:** Pere Lluís Mellado.
- ▶ **Compliance Officer:** Sergi Atienza.

The **Safeguarding Committee** held **quarterly meetings** during the course of the 2022-2023 season (July 2022, November 2022, February 2023, and May 2023). These meetings addressed a range of issues, from more strategic aspects, such as the deployment plan for the Child and Young Person Safeguarding System, the official appointment of Safeguarding Delegates and Coaches and the implementation approach as part of the activities carried out within both FC Barcelona and the FC Barcelona Foundation, to other more practical issues, such as monitoring the collection of background check certificates from the Central Registry of Sex Offenders and Human Trafficking, specific aspects of training for different professional groups, the organisation of awareness-raising activities, the updating of regulations and contractual clauses to improve the safeguarding of children and young people etc. Appropriately anonymised detected cases of abuse were also regularly reviewed to monitor processes and establish internal procedural improvements. As a result of these meetings, the complete implemented structure of the Child and Young Person Protection System and its various representatives are now in place, the position regarding compliance with legal protection requirements (appointed representatives, certificates collected, etc.) has been updated, and a series of actions involving both training and ongoing case monitoring have been implemented.

In addition, **working sessions** were also conducted with **all the Safeguarding Delegates** (in October 2022, February 2023 and June 2023), combining coordination-related elements (monitoring of training sessions with different groups, internal organisation of communications) with more instructional aspects (in particular, with regard to addressing each type of situation according to the Child Safeguarding Protocol and instruction on how to complete the report model). These meetings have contributed to the consolidation of a culture of safeguarding for the children and young people participating in

FC Barcelona and FC Barcelona Foundation activities and ensuring that all current Safeguarding Delegates are familiar with their roles and are communicating effectively with the Safeguarding Committee when it comes to the coordination of potential situations.

Finally, all the necessary meetings were conducted with each relevant Safeguarding Delegate for any cases detected, as well as other coordination activities related to their roles (collection of official sexual offenses background check certificates and equivalent, communications, training session organisation).



2.3. ACTIVITIES TO RAISE AWARENESS AMONG CHILDREN AND YOUNG PEOPLE

As set out in the good practices guide, awareness-raising activities with children and young people are conducted following the appointment and relevant training of their specific safeguarding personnel (Safeguarding Delegates and Coaches) and, as such, these sessions to raise awareness have yet to start in some areas, although plans are in place for their implementation over time.

In line with its philosophy of humility and teamwork, FC Barcelona has built links with entities and professionals with extensive experience in their respective fields (the Vicky Bernadet Foundation, SEER Emocional and a team from the Mossos d'Esquadra police force) which serve to ensure the quality of the content and introduce new dynamics.

Not only have these sessions been successful in terms of educating young participants about these issues, they have also served to open up new channels of communication and even led to the detection of certain external situations that were able to be addressed through the FC Barcelona Child Safeguarding System.

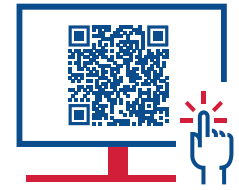
2.4. ACTIVITIES TO RAISE AWARENESS AMONG FAMILIES AND LEGAL GUARDIANS

The family awareness experience did not achieve the expected results and, as such, an adaptation was made while studying other possibilities for the future. A session on child sexual abuse prevention was organised for the Barça Academy families in Barcelona but only 40 of the 300 families participated. Due to the low turnout, the decision was made to distribute the information as a message explaining the organisation of workshops for their children and young people, which served to promote their cooperation but did not have the same impact as an in-person session. As family involvement is such a crucial aspect of safeguarding, other options will be explored to increase future participation.



2.5. ACTIVITIES TO RAISE AWARENESS AMONG SOCIETY IN GENERAL

FC Barcelona and the FC Barcelona Foundation would like to extend their actions beyond the children and young people involved in their activities, projects and programs in order to generate a broader social impact. By making the Child Safeguarding System available for free download online the idea is to encourage other sports, educational, and social entities and society at large to systematically address the wellbeing of children and young people. To that end, communication initiatives to garner public interest have been conducted across social media. (SEE ANNEX 1).

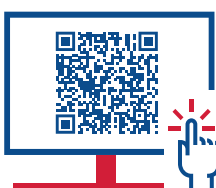

2.6. OTHER RELEVANT ACTIVITIES

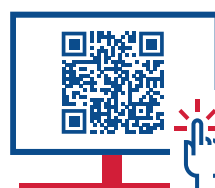
The safeguarding of children and young people in sport is a current and pressing issue. Due to the innovative nature of the FC Barcelona and FC Barcelona Foundation Child Safeguarding System, various invitations were accepted to present the model at different forums and congresses (see Annex 2). These activities not only work to raise awareness about the wellbeing of children and young people across all areas, but also provide a model that serves as an inspiration, expanding the social impact of FC Barcelona and the FC Barcelona Foundation.

The social impact of the FC Barcelona and FC Barcelona Foundation Child Safeguarding System was further reinforced through the recognition received by the Catalan Foundation for Sport in its selection of the initiative as the winner of a prestigious **Sports Awards** in the category of **Excellence, Innovation and Sustainability**. The award was presented at ceremony held in Barcelona in November 2022. The tools developed have also been disseminated in a variety of technical spaces, including presentations given to the European Council and European Union's "Pool of International Experts on Safe Sport", participation in the FIFA working group on sexual abuse in sport and contributions made to the Ministry of Social Rights and 2030 Agenda's National Strategy for the Eradication of Violence against Children and Young people in Spain. These spaces not only celebrate what has been achieved but, in the spirit of continuous improvement, also serve to inspire as opportunities to share best practices and set new challenges.

3. SITUATIONS DETECTED

The procedures for detection and reporting to the Safeguarding Committee and competent authority notification process are described in the Action Protocol. The table below shows the key data for the 2022-2023 season.

The Safeguarding Committee may intervene at the request of said teams when situations of vulnerability call for the corresponding social services to be advised.
- (8) As detailed in the Action Protocol, situations of conflict among peers are typically addressed according to educational and inclusion guidelines implemented by the coaching, sports and educational teams themselves. In the event that conflicts trigger situations of violence involving children and young people associated with the organisation, situations 5 and 6 are activated.

The Action Protocol defines **Situation 1 – Vulnerability** as “a situation in which children and young people have certain characteristics that are socially construed as an inequality or disadvantage” and is addressed through the application of educational measures to prevent any incidents occurring. As such, the coaching teams manage most situations themselves, without the need to refer to official authorities. Similarly, the Safeguarding Committee is available to offer the coaching teams guidance and advice, as happened on **one occasion** this season, offering guidance to ensure the full inclusion of each child or young person in their activities before any issues arise.

Scenario 2 – Peer Conflict is managed in the same way as in the previous scenario. The coaching, sports, educational and social teams are responsible for resolving routine conflicts between children and young people, preventing the situation from becoming more serious. The Safeguarding Committee has not been consulted in this regard (although queries have been submitted in relation to situations of peer violence, as discussed below).

Situations 3 and 4 – Suspicion (3) or evidence (4) of violence against a child or young person or violation of their rights by a person with a professional or similar connection to the entity would be treated as a particularly serious matter, as it is the responsibility of the coaching and technical teams to ensure the wellbeing of the children and young people in their care. During the 2022-2023 season, no procedures have been initiated regarding this type of situation, although queries have been submitted, in particular regarding the application of the Code of Conduct, which have been resolved with specific explanations provided to the teams concerned.

Situations 5 and 6 – Suspicion (5) or evidence (6) of violence against a child or young person or violation of their rights by another child or young person within the entity are concerning as they flag up the failure of the activities implemented by FC Barcelona and the FC Barcelona Foundation to prevent these situations from occurring and ensure positive peer interaction. However, they also indicate an effective response on the part of technical teams once a situation has been detected. **Two separate cases** have been identified related to this scenario affecting two children or young people, with a total of 24 children and young people involved in the two situations. All the steps outlined by the **Action Protocol** were followed in both cases, including alerting Social Services, the coaching team conveying a clear message against any form of violence to the groups of children and the provision of individual and collective support for all the children and young people affected.

The majority of instances (**seven in total**) in which the Action Protocol has been activated have been related to **Situations 7 and 8 – Suspicion (7) or evidence (8) of violence against a child or young person or violation of their rights by someone outside the organisation.** As anticipated, when the activities of FC Barcelona and the FC Barcelona Foundation are perceived as safe and protective environments, children and young people and their families turn to their safeguarding representatives to seek and receive help regarding external situations (in the family, at their school or related to other social and personal relations-



20 hips). In all cases, all the actions provided for by the Action Protocol have been implemented, with the competent authorities notified and the necessary support provided to each child or young person and their family, with the utmost discretion with respect to the group.

Importantly, all communication with the competent authorities (social services, law enforcement bodies) and with other entities concerned (schools, sports organisations etc.) has been very streamlined, with a positive response to the different situations and prompt activation of the corresponding procedures, as well as subsequent coordination as needed. FC Barcelona and the FC Barcelona Foundation would like to express their gratitude for the professionalism and treatment received from all the institutions contacted to address these situations and ensure the wellbeing of all the children and young people affected.



4. ACHIEVEMENTS AND CHALLENGES

The data shows that FC Barcelona and the FC Barcelona Foundation have successfully achieved their objectives with regards to the safeguarding of the children and young people participating in their activities, projects and programs during the 2022-2023 season, with new challenges on the horizon for the 2023-2024 season ahead.

One particular achievement has been the successful **training** of the majority of the professionals in FC Barcelona's sports areas (Youth Football, Women's Football, Basketball, Handball, Futsal and Roller Hockey, in Amateur Esports, and in the Barça Academy area in Catalonia, New York and Miami). The goal for the 2023-2024 season is to conduct refresher training with all these teams and extend the training to the Barça Academies in at least three more countries, in partnership with the relevant counterparts. The FC Barcelona Foundation has also successfully trained its program professionals in Catalonia and provided training and support to its counterparts in seven other countries (Chile, Colombia, Greece, Malaysia, Mexico, Peru and the Dominican Republic), with the aim of expanding the training program to five more countries. To facilitate access to the Child Safeguarding System in other countries, efforts will be made to translate key tools into English and French.

These successes are the result of effective **coordination**, both within the FC Barcelona Safeguarding Committee and the FC Barcelona Foundation, with regular meetings and consultations for the monitoring of cases, as well as in the coordination sessions with the Safeguarding Delegates and training sessions with the Safeguarding Coaches. The goal is to maintain that level of effective internal coordination throughout the 2023-2024 season and expand the coordination opportunities with the competent authorities, given the strong links established.

Raising awareness is an incipient part of the process, as safeguarding structures must first be consolidated and all personnel trained before sessions can be initiated with children and young people and with families. In fact, some cases were detected in the 2022-2023 season precisely as a result of the **sessions conducted with children and young people**, as participants found the confidence to open up to their safeguarding representatives to share their stories about situations they were finding difficult. The teams plan to review how to conduct **awareness sessions with families** to increase their impact given the challenges of attaining work-life balance in modern life. FC Barcelona and the FC Barcelona Foundation have clearly positioned themselves as a benchmark in the sphere of child protection, both in terms of implementing actions **to raise awareness among society in general** (particularly across institutional social media platforms) and participating in **other relevant activities** that presented themselves, from participation in forums and congresses to referrals and invitations from public and private institutions. The goal for the 2023-2024 season is to maintain that level of visibility and continue to promote methods for keeping children and young people safe, particularly in sports contexts.

The appropriate **actions were taken** in cases of risk for children and young people during the 2022-2023 season, with all cases having been referred to the competent authorities and using procedures in which the necessary steps have been taken. Notably, the majority of these cases involved situations perpetrated by people external to the activities, projects and programs organised by FC Barcelona and the FC Barcelona Foundation. This is an indication that the children and young people perceive these spaces as safe environments where they can seek help and know that it will be given. The goal for the 2023-2024 season is to maintain that level of response, with intervention focused on restoring the wellbeing of those children and young people affected.
