## 1. DATA CONTROLLER

Your personal data will be processed by FC BARCELONA, located at C/ Aristides Maillol, S/N, 08028 of Barcelona (Spain) and with Tax Identification Number] G-08266298.

### 2. PURPOSES

Your data will be processed for the following purposes:

In any case, the member, when providing us with the data of third-party payers, guarantees that has informed them and is authorized to provide such data.

The data of the minor members will be treated for the sole purpose of managing the payment of their membership fees through financing by the designated payer, either by the parents/legal guardians or authorized third parties.

### 3. DATA RECIPIENTS

Your data and those of third party payers as appropriate are confidential and will be only communicated to Financiera Española de Crédito a Distancia, EFC, S.A. with CIF A-84101682 (hereinafter, FINDIRECT), as the financial entity responsible for the analysis of your application and, if applicable, the subsequent granting of financing.

Your data relating to the non-payment of the FC BARCELONA membership fees for the entire 2025 season (amount of the debt, number of unpaid fees, claims made by the financial institution) may be transferred to FC Barcelona for its management, claim against the member on behalf of the financial company and for disciplinary measures for non-payment of fees. In any case, FC Barcelona will act as a service provider for the financial company and as a data processor (debt management and claims).

Except for the communications indicated above, your data will not be transferred to any third party, except for legal obligation.

Your data may also be processed by our service providers, who carry out certain activities for us but who will only access the data necessary for the provision of the service by virtue of the data processing order, and who in no case will process the data for their own purposes. All our suppliers go through a prior approval process.

Some of these suppliers may be located outside the European Union, as indicated in the next section below.

### 4. INTERNATIONAL TRANSFERS

FC BARCELONA, as an entity with an international scope, has international suppliers that may provide their services from outside the EU, so it is possible that your data may be processed outside the European Union or the European Economic Area (e.g., newsletter service provider, data storage provider, etc.).

In any case, we will ensure that said data processing is always protected with the appropriate guarantees, which may include:

## 5. DURATION OF PROCESSING

Without prejudice to said periods, your data may be kept in an anonymised form for statistical or market research purposes, where possible.

### 6. RIGTHS IN RELATION TO YOUR PERSONAL DATA

Any person can withdraw their consent at any time when it has been granted for the processing of their data. In no case, the withdrawal of this consent conditions the relationships generated previously.

You can also exercise the following rights:

- To object to our commercial shipments based on the legitimate interest in each email you receive.
- Request access to your personal data or rectification when they are inaccurate.
- Request its deletion when, among other reasons, the data is no longer necessary for the purposes for which it was collected.
- Request the limitation of your treatment in certain circumstances.
- Request opposition to the processing of your data for reasons related to your particular situation.
- Request data portability in the cases provided for in the regulations.
